In her postdoctoral fellowship, Olivia works with the evaluation team on the Bloomberg Overdose Prevention Initiative – a multi-year campaign focused on seven states to implement evidence-based overdose reduction strategies. Prior to her postdoctoral fellowship, Olivia paired her doctoral work with full time employment in Louisiana’s Medicaid evaluation center for six years. In this role, she conducted policy research and program evaluation, including an evaluation of Louisiana’s pre-release Medicaid enrollment program. Her dissertation examined

HIV care after release from Louisiana state prison custody relative to participation in state-run pre-release linkage to care programs. Olivia's most recent projects focus on access to opioid use disorder treatment, naloxone access, xylazine as a drug supply adulterant, incarceration and access to substance use treatment, and hepatitis C elimination.
